

## **AN IMPORTANT POINT THAT MUST NOT BE IGNORED:**

The illegal mining invasion in Amazon can irreversibly damage the uncontacted indigenous population.

In Amazon, there are several indigenous folk from diverse ethnicities that never made contact with the white man.

In September 2020, Riel Franciscato, one of the greatest references in the role of protecting the Amazon's isolated indigenous folk, was killed by an arrow to the chest, because he went inside the indigenous reservation while ignoring the restricted entry warnings.

His intention was to just check on the migration of the isolated folk, he defended the non-contact with said group and worked to avoid conflict with the local population, he collaborated with the team that demarcated the first exclusive land for the isolated indigenous folk. And died by invading the territory.

This invasion from the gold-mining poachers strengthened by the government, can generate an unprecedented massacre, genocide, ethnocide, en masse.

It would be the 1500s all over again.

Genocide again, the white man forcing contact chasing profit only.

We need to fight for this cause, because these people preserve nature, take care of the rivers, thanks to them we're alive, breathing.

It is essential to emphasize that the flying rivers of the Amazon forest interfere on the climate of most of the brazilian territory, because the air humidity is stopped by the Andes Mountain Range and can't rain down, so it goes back to the continent, providing humidity to the other brazilian regions.

It is worth mentioning, that it's provided for in the constitution of the Republic of Brazil, from 1988, in the articles 231 and 232, clearly and explicitly:

- It is recognized to the indigenous population its social organization, customs, languages, creeds and traditions, and the original rights over the land they traditionally occupy, delegated to the union to demarcate them, protect them and enforce respect onto all of their property.

- The indigenous folk, their community and organizations are legitimate parties to join the defense of their own rights and interests, with the intervention of the public ministry on all steps of the process.

The state is not fulfilling its duty with the indigenous folk, after COP 26, indigenous people of all ethnicities and from all around the brazilian territory, began suffering attacks of the most radical manner.

The government didn't like the traction that the indigenous cause reached outside the country, and is systematically attacking everyone, the media isn't reporting because it is being censored.

Fear plagues Brazil.
